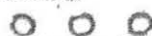

WATCHMAN IS UNDER ARREST

Government Authorities Say Missing Link is Found in Koenig Case.

New York, Dec. 22.—Edmund Justice, a night watchman employed by the Atlas Steamship Company, a subsidiary of the Hamburg-American line, was arrested by federal officers this afternoon charged with being a party to conspiracy against the entente allies. With his arrest the authorities believe they have found the missing link in the Paul Koenig case. It is charged that at Koenig's direction, Justice accompanied Frederick Metzler, who is also under arrest, to Quebec and there sought to determine the number of troops being sent to the United Kingdom, what ships they would sail on together with details of artillery equipment and other supplies being sent abroad.

The grand jury in the Koenig case finished its work today but no indictments are expected until after Christmas.

Sweitlik is said to have shot himself about 7 o'clock Monday night. He had been ill for a period of perhaps three years preceding his death and the acting coroner believes that this prompted the act.

MANSFIELD COCA COLA CO. IS INCORPORATED TODAY

Coca-Cola Bottling Company

THREE COUNTIES WILL BE INCLUDED IN TERRITORY OF LOCAL CONCERN.

Announcement was made today that the Mansfield Coca-Cola Bottling Company had been incorporated with a capital stock of \$10,000 by H. C. Gram, George M. Gerhardt and Henry Frankel of Cleveland. These men at present control two other Coca-Cola bottling plants, one of which is located at Cleveland and the other at Buffalo. At present all of the Coca-Cola that is sold in this city is shipped from Cleveland and is a great disadvantage to the local merchants as delays in shipment are frequent.

This company will occupy the building formerly used by the Perfection Bed Spring factory on North Diamond street. The Mansfield branch will be under the management of George P. Gerhardt, Jr., who has had much experience in this line. Mr. Gerhardt is an enterprising business man and will be a valuable addition to the city at large as he has always been interested in the business affairs in other cities in which he has been located.

Three counties will be included in this territory and all shipments will be made direct from the local plant. Ashland, Crawford and Richland counties will be taken care of by this concern. The delivering will be done with large auto trucks. Three trucks have been ordered and are expected to arrive in the near future. These trucks will make deliveries to the nearby cities.

The new machinery for the manufacture of this popular drink is expected to arrive within the next few days and everything is being prepared

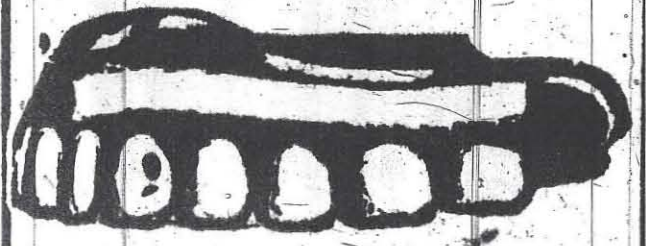

Children's Home.

The Children's home is very well supervised and the trustees, as well as the superintendent, are to be given much credit for what they have done at this institution. The board of county visitors has in other reports, expressed itself as to the advisability of having a hospital ward located in a building separate from the home. Each year the Children's home has been quarantined for some contagious disease which has broken out within it. The lives and future welfare of the children in the home are in danger whenever there is a case of contagious disease within the main buildings. We feel that there should be a separate hospital building, a part of which should be devoted to detaining all children arriving at the home, for a period long enough to ascertain whether or not they have been exposed to some contagious disease and are liable to carry it into the home. One year ago, and also this fall, the cases of scarlet fever and case of diphtheria were brought to the home by new children that were placed there. If these children could have been detained in a separate building for a period long enough to show conclusively whether or not they had contracted a disease and were carriers of it, there would have been no necessity for quarantining the home at either time and the lives of the other helpless children would not have been in danger. In addition to this hospital building being used as a detention for incoming children, one section of it should be used for all children who are sick so as to remove them from the noise and confusion that is naturally incident to a large building full of children. Another section of the hospital would be devoted entirely to
