"After our practice was over, tea was served on a white cloth in a refuge down below in the depths of the earth, secure against shrapnel.

"Today the same position will be occupied by three French guns and one English gun; tomorrow by two French guns and two English; next fur by three English and one French. All this time the battery will be commanded by a French battery commander, who hitherto has never seen British gunners. Only when the battery consists of four English guns will a British officer take command of it. Until then he will remain as long as necessary receiving with his British gunners, indications and instructions with regard to the country drawn from the experience of French gunners, who have held the position since November, 1914. Only one man can command a battery of four guns, and that is always the man who has been longest on the spot,
