EDISON — Lloyd Lauren "Bud" Wire, 78, of West Vine Street died Friday afternoon, March 22, 1996, at his home.

He was born Jan. 28, 1918, in Ashley to Franklin O. and J. Grace Aldrich Wire. He lived in the Ashley area until moving to Edison in 1966. He was an Army veteran of World War II. He worked for the Columbus Dispatch until 1951 delivering newspapers to many communities in central Ohio. He retired in 1983 from H.P.M. Corporation in Mount Gilead, where he had worked as a machinist, foreman and tool-and-die maker. He was a member of the Edison United Methodist Church. He had served as scoutmaster for the Ashley Boy Scout Troop 94 for 17 years and was a member and past commander of the Ashley American Legion Post 518. He also served on the Ohio State Highway Patrol Auxiliary from 1949 to 1966. He was also an avid deer hunter and bowler.

He is survived by his wife, Freda J. Wertz Wire, whom he married May 7, 1966; a sister, Emma Coleman of Ashley and several nieces and nephews.

He was preceded in death by a brother, O. Floyd McFann; and two sisters, Anne Johnston and LaVerne Reichardt.
