A DIVORCE PETITION WHICH MAKES SOME STARTLING ALLEGATIONS.

John Ohl, of Shelby, Charges his Wife With Adultery and Eloping With the Destroyer of Bis Marital Happiness.

A divorce case of more than ordinary interest was begun in Common Pleas Court today. John Ohl, of Shelby, is the plaintiff and in his petition he alleges that his wife, Rebecca Ohl, is guilty of adultery with Charles Wertman, in this city on Jan. 15th.

Mr. Ohl in his petition says that for some time Wertman boarded with him and an intimacy sprang up between him and Mrs. Ohl. On last Monday Wertman left the house, saying he was going to his old home in Ashland for a short stay. On the same evening Mrs. Ohl came to Mansfield, ostensibly to visit friends, since which time the plaintiff in the case has seen neither of the parties.

Mr. Ohl says that on Tuesday evening when he went home he found that his wife had taken a great quantity of wearing apparel. This aroused his suspicions and on the following day he came to Mansfield to investigate. The whole situation soon burst upon him and the shock to his nervous system was great. He says that he learned, upon inquiry, that Wertman went to Ashland last Monday, packed his belongings and came to this city on Monday evening, where he met Mrs. Ohl according to appointment. The guilty couple spent that night at one of the hotels in the north part of the city and, on the following morning, boarded a west-bound train and shook the dust of Mansfield and Richland county from their feet. Mr. Ohl has no idea where his spouse and her companion now are.

The parties in the case are well known in Ashland and the northern part of this county. The plaintiff has the contract for carrying the mail from Ashland to Adario. He is the son of Stephen Ohl, of Ashland, and, on June 24, 1877, he married the wife who so unceremoniously deserted him and disgraced the family name. Wertman is well known in Ashland, where he followed many avocations. Latterly, however, he has been pettifogging in that section and was waiting for clients when he boarded with his old friends in Shelby. Wertman was married a number of years ago and only two weeks ago his wife was decreed a divorce from him on the grounds of failure to provide, etc.

Fortunately neither Mr. Ohl nor Mrs. Wertman are left with any children, none having been born to either of the mismated couples.

Some of Stone's friends think that he is mentally unbalanced or suffers from periodical fits of insanity.

Last spring Stone was elected constable on the Republican ticket, but refused to serve.

BIGAMIST BEATTY.

Prosecutor Douglass Tells Why He Was Not Prosecuted.

Recently the indictment against Harry Beatty, charging him with bigamy, was nollied in the Common Pleas Court upon Prosecutor Douglass' motion. Beatty, it will be remembered, came to this city about three years ago and, after a short acquaintance, married Miss Fannie Hedges, of 24 North Diamond street.

Beatty remained in this city a short time and then went to Dayton. Friends of the bride interested themselves and found that Beatty had another wife living at or near Dayton. The matter was referred to Prosecutor Douglass and an indictment was found against the bigamist, and after considerable trouble and expense and some delay Pratty was lodged in jail. The prisoner's friends secured his release on bail and Beatty went to Pittsburg.

The prosecutor this morning received a letter from an acquaintance of the Mansfield Mrs. Beatty, in which some serious charges are made, concerning the withdrawal of the criminal proceedings. Mr. Douglass today told the Shield just how the indictment came to be nollied, which should satisfy everybody concerned in the affair.

He said that when the indictment was found against Beatty he spent his own money and time to lodge him in jail and bring him to justice. After the prisoner was released on bail Mrs. Beatty No. 2 sent for him several times and asked him to nolle the indictment against her husband, as he had already been punished enough and she did not want to send him to the penitentiary. It was in response to the urgent pleadings of Mrs. Beatty, of this city, says Mr. Douglass, that the indictment was nollied.
